



Invitation to Bid for the Proposed Slope Protection (Gabion) Works

1. The Philippine Mining Development Corporation (PMDC) through the Corporate Operating Budget (COB) intends to apply the sum of **One Million Four Hundred Ninety-six Thousand Seven Hundred Seventeen pesos and 72/100 (Php 1,496,717.72)** being the Approved Budget for the Contract (ABC) to payments under the contract for Proposed Slope Protection (Gabion) works. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. PMDC now invites bids for Slope Protection (Gabion) works. Completion of the Works is required within **Forty (40) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from PMDC and inspect the Bidding Documents at PMDC Davao Office, Suite 077, 7th Floor, Pryce Tower Building, Pryce Business Park, J.P Laurel Avenue, Bajada, Davao City, during Monday to Friday from 9:00AM to 4:00PM

A complete set of Bidding Documents and Financial Bid Form template may be acquired by interested bidders on **5 August 2021 until 12:00NN of 24 August 2021** at PMDC Davao Office, Suite 077, 7th Floor, Pryce Tower Building, Pryce Business Park, J.P Laurel Avenue, Bajada, Davao City, during Monday to Friday from 9:00AM to 4:00PM and upon payment of the Bidding Documents amounting to **Five Thousand Pesos Only (Php 5,000.00)**

Financial Bid Form and Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The PMDC will hold a **Pre-Bid Conference** on **11 August 2021, 2:00PM** at PMDC Davao Office, Suite 077, 7th Floor, Pryce Tower Building, Pryce Business Park, J.P Laurel Avenue, Bajada, Davao City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 24 2021, 12:00NN**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **24 August 2021, 2:00PM** at PMDC Davao Office, Suite 077, 7th Floor, Pryce Tower Building, Pryce Business Park, J.P Laurel Avenue, Bajada, Davao City. Bids will be opened in the presence of the bidders' representatives who choose to attend. **Late bids shall not be accepted.**

8. PMDC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
