Mindanao – Bids and Award committee issued a Mindanao BAC Resolution No. 1, Series of 2020 for the Failure of Procurement Activity and Bidding Process for the said project.

The Mindanao BAC proceeded then with the posting of Invitation to Bid (ITB) for the Second Bidding and scheduled procurement activities pursuant to existing rules and regulations. Through the ITB and Supplemental/Bid Bulletin No.2 series of 2020, Pre-bid and Opening of Bids was scheduled on 11 February 2020 and 24 February 2020 respectively.

Mindanao BAC convened on 11 February 2020 at exactly 2:00PM for the Pre-bid Conference attended by 3 out of the 5 regular members of the BAC.
