Mangga, corner Luisa St, Juna, Davao City, or PMDC Depot Field Office, respectively, starting **April 15, 2024**, until **April 24, 2024**, from **8:00 a.m. up to 5:00 p.m.** Pre-bid conference will be conducted on **April 19, 2024**, at **10:00 a.m.**, through a hybrid, either personally or via Zoom meeting to be provided by the PMDC.

The bid proposal must be submitted to the Disposal Committee in a sealed envelope, with one (1) original and two (2) duplicate copies, **on or before 10:00 a.m. on April 25, 2024**, on the 2nd floor of SouthDev Bldg. Mangga, Corner Luisa St, Juna, Davao City. The clock in our Davao Office shall serve as the basis for the official time for this bidding. Bid proposals received after the above deadline shall no longer be accepted. Bid envelopes will be opened by the Disposal Committee at **10:15 a.m. on April 25, 2024**, at PMDC Davao Office located on the 2nd floor of SouthDev Bldg. Mangga, corner Luisa St, Juna, Davao City.

The inspection of lots to be disposed of will be held from **April 15, 2024**, until **April 24, 2024**, during working hours from **8:00 a.m. - 4:00 p.m.** at the PMDC Depot Office located at Sitio Depot, Upper Ulip, Monkayo, Davao de Oro, ComVal Province. A certificate of site inspection will be given immediately thereafter.

INSTRUCTIONS TO BIDDERS

1. Only those who secured the bid documents (Terms of Reference and Bid Form) from the **PMDC BAC Disposal Secretariat** shall be allowed to bid.
2. Participating bidders are advised to inspect the items, sale per lot, at the **PMDC Depot Office** at Sitio Depot, Brgy. Upper Ulip, Monkayo, Davao de Oro, at the specified time and date indicated in the Invitation to Bid. The Disposal Technical Working Group (TWG) shall issue a site inspection certificate, which the bidders shall submit with their bid proposal during the bidding.
3. Bid proposal, together with the **three (3)** duplicate copies, Certificate of Site Inspection and Bid Bond, shall be placed in a sealed envelope and must be submitted **on or before 10:00 a.m. of April 25, 2024**, at the **PMDC Davao Office** located at 2nd floor SouthDev Bldg. Mangga, Corner Luisa St, Juna, Davao City. The official time shall be based on the clock of PMDC's Davao Office. Late bids will not be accepted. **Bid envelopes will be opened by the Disposal Committee at 10:15 a.m. on April 25, 2024, at PMDC Davao Office located on the 2nd floor of SouthDev Bldg. Mangga, corner Luisa St, Juna, Davao City.**
4. The bidders shall indicate their bid price in the Bid Form provided by the PMDC Disposal Secretariat, which should be handwritten clearly and legibly in words and figures. In case of a discrepancy between the prices in words and figures, the price given in words shall prevail.
5. Bids must be written in print with the use of permanent ink and shall be signed by the bidder or the duly authorized representative of the bidder. The person signing the bid shall initial all the pages of the bid.
6. Erasure or alteration as necessary to correct errors made by the bidder or the duly authorized representative of the bidder may be allowed in the forms and documents provided that such correction/erasure shall be duly initialed by the person signing the bid. Failure to initial such correction/alteration shall result in outright rejection of the bid.
7. Bid Bond equivalent to 10% of the total bid price shall be either in the form of cash or manager's/cashier's check from a commercial or universal bank. Submitting a Bid Bond less than the amount required shall result in the rejection of the bid. The Bid Bond shall guarantee that the winning bidder shall pay its bid price per awarded lot/s within the period of five (5) working days from the receipt of the Notice of Award. In case of failure, the Bid Bond shall be forfeited in favor of PMDC.
8. The Bid Bond of non-winning bidders shall be returned after the bids have been evaluated and the winning bidder has been announced, confirmed, and approved by the PMDC

president. The bid bond of the winning bidder shall be returned after the PMDC receives the full payment of the total bid price of the lot/lots awarded to the bidder.

9. Failure to pay within the prescribed period and accept the award by the winning bidder will result in the cancellation of the award and forfeiture of the bid bond. Subsequently, the award will be given to the second highest bidder, who will post a new bond upon acceptance of the award.





GENERAL TERMS AND CONDITIONS

1. The disposal of unserviceable equipment is on an “**as is where is basis**” at the PMDC Depot Office located at Sitio Depot, Brgy. Upper Ulip, Monkayo, Davao de Oro.
2. The bidders may bid on any lot or all the lots being bid out, but the contract shall be awarded per lot.
3. The bid shall be in lump sum price per lot.
4. The award will be given to the bidder offering the highest price per lot.
5. The winning bidder shall assume all labor, administrative costs or charges, taxes (e.g., VAT and DST, Withholding tax, if any), and other incidental expenses for the contract, including the hauling/withdrawal of the subject materials from the present location of the lot(s).
6. Withdrawal and hauling of materials under the awarded contract shall be made only during office hours, from **8:00 a.m. to 4:00 p.m.** on regular working days. The withdrawal/hauling should be duly coordinated with the PMDC Disposal TWG.
7. The withdrawal/hauling shall be completed within the period fixed by the Disposal Committee, reckoned from the receipt of the Notice to Proceed.
8. The winning bidder shall have the sole obligation/ responsibility over any possible untoward incident that may arise during the execution of the contract. All unforeseen risks or force majeure that may occur shall be the responsibility of the winning bidder unless through the delay/default done by the PMDC.
9. Payment of the total bid price for the lot/s awarded shall be made to the PMDC within five (5) working days from the receipt of the Notice of Award in the form of cash or cashier's/manager's check or any other digital modes of payment in accordance with EO No. 170, s. 2022 or existing laws, rules, and regulations. Thereafter, the Notice to Proceed will be issued for the commencement of the works.
